## Annual Legislative Visit

The American Public Transportation Association (APTA) annual Legislative Conference was held in Washington D.C. early in March this year. The conference is attended by hundreds of mass transit leaders from across the Nation joined by the suppliers of equipment and services for the transit industry. I attended along with TTA Assistant Manager, Jennifer Woodall, and representatives from other WV transit systems.

This is a particularly critical year for the conference. The legislation that provides federal funding for TTA and mass transit systems throughout West Virginia and the USA has undergone major changes this year.

At the conference, we heard from people like the U.S. Secretary of the Department of Transportation and the chairman of the U.S. House Committee on Transportation and Infrastructure. **Congressman Nick Rahall** (D-WV) is the Democrat who is second in seniority on that committee and in a powerful position to influence authorization.

On the final day of the conference we went to "The Hill" and met with our elected officials to remind them of the importance of mass transit services in West Virginia and the elements in upcoming legislation that will have the greatest impact on promoting and expanding our transit operations "back home." We were able to meet in person with **Congressman Rahall** and **McKinley**. **Senators Manchin**, **Rockefeller** and **Congressperson Capito** were not available, but assigned key staff personnel to meet with us.

Reauthorization of the transportation bill known as "MAP 21" and the TMA were the main items on our agenda. As you may recall, the bill is a 2 year term bill and will expire in FY 2014.

All agreed that this was a great time to discuss reauthorizing mass transit legislation. Why? The Country has four major challenges facing it today. They are the economy, the environment, energy independence and the quality of life in America. TTA is representative of most transit systems in our ability to help the Country address all four of these challenges.

TTA is all about jobs and economic development. Customers ride our buses and "Dial-A-Ride" for one or two major purposes –

to earn money or to spend money. Neither happens if you can't get from here to there. TTA helps reduce the pollution that is created by automobiles. Imagine how much more carbon would be in our air if the 931,071 trips on TTA last year had made instead in single occupant automobiles! Think as well of how much fuel is saved by all the TTA customers who board a bus instead of turning the ignition switch on or calling a taxi. It is now widely accepted that mass transit will play a key role in reducing our nation's dependency on foreign oil.

Finally, is the most personal role TTA plays in the communities we serve. Customers who cannot drive can still go where most everyone else goes for entertainment, socializing, shopping, health care. education and the marvelous array of services available to the residents of the tri-state area. Customers who choose to drive less or not to drive at all have a choice.

Our time has come. Thank you to all who read our newsletter for the role that you have played in getting TTA where it is today.

#### **Performance Report**

Ridership for the month of January is down by 2,462 customers. The Dial-A-Ride ridership had an increase of 671 customers The bus side of the too. system decreased by 3,133 customers. As for year-todate statistics, bus ridership is down 727,733 trips or 5% and Dial-A-Ride is up 1229 or .07%.

The cost of operation in January 2013 was \$12,865.64 more than in January 2012 and \$44,948.66 less than budgeted. Year-todate operating expenses have increased one percent and are eight percent below budget.

Operating revenue in January was \$11,777.03 more than in January 2012 and \$15,700.19 more than budgeted. Year-to-date revenue is \$48,428.40 over FY 2012 and \$56,062.41 more than budget. **JOKES**

## SHOP TALK

As TTA's fleet gets older, the cost of repairs increases. TTA's 2003 model Gillig buses are reaching 345,000 miles and in the past six to eight months, the Maintenance Department has replaced (3) rear-ends on those models. Also, we have replaced some major ISL components on the

Cummins engine which would be (2) Caps fuel injector pumps on the 2003 model and (2) injector pumps on the 2009 model Cummins engine. We recently finished replacing a head on the injector pump on Bus 1760. Back in March, the Maintenance Department had to replace the Catalyst filter in the muffler system on one of the 2009 model buses at a cost of around \$7,000. Our Dial-A-Ride vans are no exception to requiring major repairs. Recently we have had to replace the transmission in (2) of our vans. As we all can tell, the cost of keeping our fleet in good running condition comes at a high price, but bottom line, the Maintenance Department at TTA is fortunate to have the experienced mechanics and cleaners we have to keep our buses safe and clean for the public.

#### **Open Enrollment**

Once again, it's time for PEIA's annual Open Enrollment. The Open Enrollment for the new plan year will run from 1 April 2013 to 30 April 2013. The coverage you select during this period will be effective on 1 July 2013.

Around the end of March, you will receive the annual *Shopper's Guide* from PEIA that provides a detailed discussion of your options. There are several changes to the insurance options and coverage amounts during the upcoming year. I will briefly cover a few of the changes here, but I recommend that you carefully review the *Shopper's Guide* before making your insurance decisions.

The good news is that the rates for active employees will not change for the upcoming year. The rate that an active employee is currently paying will be the rate he/she will continue to pay after 1 July 2013 (assuming he/she does coverage make not any changes during open enrollment).

The most-prominent announcement this year is related to the tobacco-free discounts. ALL employees and retirees must re-affirm their tobacco-free status during the month of April 2013. In addition, you will NOT be able to use the paper affidavits we have used in the past to tobacco-free confirm your status. Instead, you will need to call the Open Enrollment Help Line (number listed in the Shopper's Guide) and confirm your tobacco-free status. Failure to make this call will automatically result in the revocation of your tobacco-free status (and an increase in your monthly premiums). You can begin calling the PEIA number to confirm your tobacco-free status on 1 April 2013.

There will be several changes to the retiree rates and coverage options in the upcoming plan year. There will be new retiree plans available and different rates for each of them. I do not have the space

to discuss all of the changes, but PEIA is sending out a letter to retirees that will describe those changes. I would HIGHLY recommend that all retirees attend one of the Benefit Fairs offered by PEIA during April. Counselors will be on hand during the meetings to discuss all of the changes with you. They have been through specialized training to understand and explain all of the changes.

There will also be some changes in the optional life insurance options. PEIA will be adding a new level of dependent life insurance benefits for active employees (not for retirees). The new level will be \$40,000 for spouse and \$15,000 for each dependent child. If you wish to dependent increase your coverage, then you will need to evidence obtain the of insurability form from PEIA and complete it to request the increase in coverage.

Another life insurance change is that active employees will be able to increase their optional life insurance coverage one level if there are any qualifying family events during the plan year. This is an added benefit to employees this year.

At this time, PEIA does not plan to have an open enrollment period for optional insurance coverage. life However, you may increase your coverage at any time if you wish to go through the evidence of insurability process.

Next, if you participated in the Improve Your Score (IYS) program last year, then you will be receiving an affidavit from PEIA to continue it during the upcoming year. If you wish to join either the IYS program, then you should contact PEIA to get started. Note that TTA will not have the forms needed to participate in these programs, so they must obtained directly from be PEIA. You need to let me you choose to know if participate in one of these programs because we will not receive a list of participants from PEIA.

In addition, the Health Plan (HMO) has added a new option (Plan C). Currently, no TTA employees are using the HMO plans, but the information about their changes are available in the *Shopper's Guide* if you are interested in looking at those options.

PEIA will continue to use the online open enrollment this year that it started using a few years ago. You will not receive an Open Enrollment Change Form in the mail unless you contact PEIA and request one. However, you **MUST** update your tobacco-free affidavit during the month of April to receive the discount in the new plan year.

Obviously, there are too many changes to the insurance options for me to list here. That is why it is so important for you to review the *Shopper's Guide* before making your coverage decisions. There will be toll-free numbers and websites listed on the back of the *Shopper's Guide* for you to use if you have additional questions regarding your options.

Finally, PEIA will host benefit fairs throughout the state again this year to answer your insurance-related questions. A full listing of the fairs' times and locations will be in your *Shopper's Guide*. The fair in Huntington will be at the Big Sandy Superstore Arena on 18 April 2013 from 3:00 PM to 7:00 PM. Please plan to attend the benefit fair if you have any questions about your insurance coverage.

## At The Capital SB 188

Representatives from the WV Public Transit Association attended the Senate Health and Human Services Committee meeting March 14<sup>th</sup>, 2013.



J Carter, General Manager of Potomac Valley Transit Authority (pictured above) presented to the Committee the Association's concerns regarding Senate Bill 188.

Senate Bill 188 states that the Secretary of DHHR shall develop a vendor transportation program for the transportation of Medicaid clients to covered services. In essence it will bring a Broker into the state to manage the non-emergency medical transportation for DHHR in an effort to reduce waste and fraud, the majority of which occurs with "friends and family".

In an effort to preserve valuable resources, Senator **Kirkendoll** (Logan County) introduced the amendment which would allow public transit programs receiving funding from the State or Federal Transit Administration for the purpose of providing general public transportation to with contract the transportation vendor but are not required to do so in order to provide non-emergency transportation services to Medicaid recipients. As well. Ambulances licensed under provisions of the the **Emergency Medical Services** Act in Chapter 16, Article 4c of WV Code may transport Medicaid clients but shall not be included in the vendor transportation program. The Committee also included Senior Service Centers to the amendment.

Senator Evan Jenkins (Cabell County), also weighed in asking Cynthia Dean (DHHR) if the Department has an issue with the quality or cost for services provided by public transit. Ms. Dean responded that the Department does not have a problem with the quality or cost of service provided by public transit.

The amendment passed the committee vote and was referred on to the Senate Finance Committee. As of the date of this article, the bill has yet to be brought up in the Finance Committee.
